Copies of the 2021 St. James United Church Annual Report document were e-mailed out in advance of the meeting to all congregation members and paper copies available upon request.

Call to Order

Board Chair, Jane Huggins, called the meeting to order and expressed appreciation for all who were in attendance, and expressed heartfelt thanks for all who supported the church and Board during a challenging year.

Jane Huggins made a motion that Rev. Julie van Haaften act as Chair for the meeting. The motion was seconded by Marney Horton. CARRIED.

Jane Huggins made a motion that Leslie Gutsole-Floyd act as recording secretary. The motion was seconded by Jayne White. CARRIED.

Permanent Motions:

Leslie Gutsole-Floyd read the permanent motions (as passed at the Congregational meeting of Feb. 21, 2010) as follows:

"For the Official Board to have the authority to carry out the duties that would normally fall within the responsibility of the congregation between Congregational meetings."

"To allow additional people to join the various committees anytime throughout the year without having to come to the congregation."

"That Adherents have the right to vote on issues at the meeting on temporal matters, this covers the work, life and finances of the church."

Minutes

Minutes of the June 20, 2021, Congregational meeting were available in the 2021 St. James United Church Annual Report on pages 9 to 11. Peggy Fillier made a motion to accept the minutes as written. Fred Batley seconded the motion. CARRIED.

Election of Auditors

Jane Huggins made the motion that Angus Fitzgerald and Joanne Rorke be the auditors for 2022 and shared that both had agreed to have their names stand for the position. The motion was seconded by Lynda Parker. CARRIED.

Nominations Committee

Rev. Julie van Haaften drew attention to the names of members currently listed for each committee and read aloud the new member names as listed in the 2021 St. James Church Annual Report on pages 8. The following additional names were added to the printed list. Fundraising Committee: Natalie Dorsett, Jim Mills. Stewardship Committee: Leslie Gutsole-Floyd. New Canadian Centre Lease Committee: Lynda Parker, Fred Batley, Ron Horton, Jane Huggins, Rev. Julie van Haaften. A motion was made by Jim Lowes and seconded by Shirley Rolufs to accept the committee nominations list as amended. CARRIED.

Financial Report

Ron Horton reviewed the 2021 financial report section by section as printed in the 2021 St. James Church Annual Report on pages 29 to 35. He gave an overview of each page and answered questions from the floor regarding signing authority and banking cards. Signing authority is restricted to the Treasurer, Chair of Trustees and Chair of the Board. There are no banking cards. After opportunity for any further questions, a motion was made by Peter Floyd to accept the financial report for 2021 as printed. It was seconded by Fred Batley. CARRIED.

Budget 2023

Ron Horton reviewed the 2022 proposed budget, as recommended by the Official Board and printed in the 2021 St. James Church Annual Report on pages 36 and 37. He reviewed it section by section, answering questions. The preparation of the budget was challenging due to the continuing restrictions and uncertainty brought about by COVID 19, including continued reduced rentals, reduced envelope givings, and decreasing government subsidies. After discussion, a motion was made by Shirley Rolufs to accept the 2022 budget as printed in the 2021 St. James Church Annual Report. The motion was seconded by Joyce Hodson. CARRIED.

The on-going and tireless work that Ron Horton has done as Treasurer was recognized and his efforts appreciated.

Committee Reports

The 2021 St. James Annual Report contains reports from committee on pages 14 to 25. After opportunity for questions, a motion was made by Jim Lowes to approve the Committee Reports as printed. The motion was seconded by Lynda Parker. CARRIED.

Staff Appreciation

Peter Floyd expressed heartfelt thanks to each of the church staff for their hard work, talent and on-going support for St. James Church. Their abilities to pivot and creatively adapt their roles during the continued CO-VID 19 pandemic were recognized.

Rev. Julie van Haaften thanked Committee members leaving their positions on the Board: Joanne Rorke, Susan Weaver, Leslie Gutsole-Floyd, Peter Floyd, Bill Bott, Dianne Hutchison.

New business:

<u>Stewardship Committee and Fundraising Committee update</u> - Natalie Dorsett shared that, despite the pandemic, the Committees have been very busy. Giving Sundays are planned for the first Sunday of each month beginning in March and will highlight an area for possible donations above and beyond the usual donation (e.g., snowplowing). Other possible events for 2022 include an online auction, gift baskets, baby photo contest, Brian's Broadway, St. James cookbook, and cooking night. In addition, our newly renovated space will be promoted for rental, highlighting the tech and ability to livestream. A donation button will be added to social media pages where possible. Committee members welcome any further ideas from congregation members.

<u>CO-VID 19 Sub-committee update</u> – Fred Batley reported that as of March 1, 2022, many of the CO-VID restrictions will be lifted. A vaccine passport will no longer be required. Masking and social distancing with passive screening (i.e., notices at entrances asking people to self-screen) will continue. Renters and groups within the church may choose to maintain lifted restrictions.

<u>Marketing Committee update</u> – Fred Batley shared that they have been busy promoting the newly renovated space at St. James. The church website is being redesigned to include a video that will highlight the stage, lighting and tech available. On March 26, 2022, the committee will host a focus group who will tour the space and discuss its possible uses. The committee hopes to get useful feedback on how to move forward in promoting the space. The Board has agreed to the tagline "Faith, multi-cultural and arts centre" to be used to describe the space and has named the newly renovated area as "Wesley Hall" for rental purposes. It is hoped that future focus groups will extend to include partnerships with drama, art and other community groups. A leasing agent will be consulted regarding any other possible rental options.

<u>Other</u> – Eileen Stanbury expressed disappointment over the cancellation of summer camp this year.

Thanks – Rev. Julie van Haaften expressed her thanks to an amazing congregation.

Gift Cards

I would like to extend a big hearty thank you to everyone who purchased Gift Cards during 2022. A total of 1,367 cards were ordered resulting in a profit of \$2,073 for St. James. Due to the Covid-19 pandemic and the fact that the church was closed occasionally, orders for cards were down slightly over 2021. Also, during lock down, it was occasionally necessary to hand deliver gift cards to purchasers. Orders picked up again during the period from October to December mainly due to Christmas orders.

The beauty of this program is that you put your regular household shopping dollars to work. You earn money for our church without spending anything additional. Just spend your family's regular shopping dollars at the stores that participate in the program. Gift cards can be used for just about any purchase including food, clothing, entertainment, furniture, building supplies, auto repair, gasoline, dining out and much more. Look at it as paying for products and services in advance. There is absolutely no extra out-of-pocket expense to you. You only spend what you normally do for these items.

Gift cards are available from a large number of major retailers. Popular retailers that participate in the program include: Loblaws, Sobeys, Freshco, Foodland, No Frills, Canadian Superstore, Independent, Safeway, Canadian Tire, Home Depot, Home Hardware, Swiss Chalet, Harvey's, Wendy's, , Cineplex, Best Buy, The Keg, La Senza, , Pizza Pizza, GAP, Old Navy, Kelsey's, the Bay, Lowe's, Pioneer Petroleum, Petro Canada, Esso, Ultramar, Shoppers Drug Mart, Walmart, Winners and many others.

As noted above, we earned \$2,073 in 2022. Let's see if we can achieve a goal of \$2,200 in profit for 2023. Thanks again for supporting this worthwhile fundraising opportunity in 2022. Your participation helps support our many ministries and programs and is greatly appreciated by all.

Board of Stewards

- Roof repair due to the storm on May 20th
- Georgian Bay's annual inspection and many repairs to the alarm system.
- Accessible washroom doors installed on the main floor women's washroom from a grant we received from the government.
- Posts were installed beside the NCC shed to ensure people cannot access the space behind the shed. Members of the community were found to be sleeping behind the shed, which is a safety concern due to exhaust fumes from the furnace and icicles falling from the roof.
- A pest control company was brought in to prevent squirrels, pigeons and bats from entering the building. This is an ongoing issue.
- Furnaces and boilers are inspected annually.
- Our heating system required many repairs. One of the boilers needs to be fixed and parts were ordered in 2022. Repairs will occur in 2023 when the parts are available.
- Plexiglass was replaced on one of the stained-glass windows facing Alymer Street.
- To ensure the safety of staff and the building, a camera was installed at the staff entrance and an intercom system that allows staff to speak with visitors and remotely open the doors from their desks.
- A beautiful mural, thankfully sponsored by the NCC, was painted in the entrance way and on a portion of the main floor. In order to get prepared for the painting of the mural, the walls and doors on the main floor and the entrance way were painted by some dedicated volunteers.
- Cogeco installed Wi-Fi boosters on both the main floor and the basement to improve the Wi-Fi signal. We are continuing to look into other ways to improve the signal in the building.

In an effort to limit our carbon footprint and become more energy efficient, a few upgrades were completed in 2022:

- A timer was installed on the hot water tank.
- Programmable thermostats were installed in the Sanctuary.
- Any light fixtures that needed repairs were switched to LED.

Now that community organizations have resumed normal activities, our building has come alive. We welcomed back our tenants and gained quite a few new tenants, increasing our rental income.

Thank you to our volunteers in 2022.

- Places of People- Provides affordable housing to people in Haliburton County
- Abbey Retreat Centre- Cancer support centre in Haliburton Highlands
- QHC-Spiritual Health Services- Provides spiritual healthcare to patients and their families etc. at four sites.
- Five Oaks- interfaith/intercultural Centre, serving Christian, Indigenous and Muslim Communities
- Quinte Deaf Ministries- provide Sunday services and weekly Bible studies to the deaf.
- Camp Qui- Mo-Lac- provides camping and living skills for children 7-14 plus leadership opportunities.
- Old Hay Bay Church- helps maintain the oldest surviving Methodist building in Canada.
- St Paul's UC obtaining equipment and supplies to start a Messy Church program.

The Justice Committee was looking for churches to assist in hanging portraits through Anti-racism Lens Project (achieving a better balance of white and nonwhite faces in portraits in churches).

Our board has approved hanging a picture of Murray Sinclair and possibly Murray Whetung in our church this year.

In articulating her vision for The United Church of Canada, the Rev. Dr. Carmen Lansdowne, Kwisa'lakw, speaks of a church committed: "To build new connections and rebuild old ones. To work towards social change that sees a world cared for, and human dignity honoured. To walk together every day in repentance and reconciliation. To march and fight and change unjust systems together. To pray together. To sing together. To discern together."

*4 GIC's were cashed late in 2022 (from both the restricted account and the Memorial Church Fund) due to our poor cash flow; there are now a total of seven GICs remaining to buy back (totalling \$26,770). We have been using our line of credit at times in lieu of cashing GICs; the line of credit was fully paid back by Dec. 31/22 but will be used again early in 2023. Interest paid in 2022 for our line of credit was \$219. Cashing a GIC or using our line of credit is necessary as, while our expenses are relatively even throughout the year, our revenue is not; revenue is heavily weighted towards the end of the calendar year and lowest during the May to September period. COVID 19 has had a major impact on some of our revenues for the past three years.

St. James Memorial Church Fund

Bequests are invested in 11 GICs, 5 of which have been cashed (for \$16,500) to assist our cash flow. The 6 remaining GICs total \$36,000.

We did not receive any new bequests in 2022 that were designated for the Memorial Church Fund.

Interest earned from the GICs, and the savings account is transferred to the general funds in the month that it is earned.

Comments to Financial Statements

AS OF DECEMBER 31, 2022

1. SIGNIFICANT ACCOUNTING POLICIES

a) These financial statements are comprised of the accounts under the control of the Church Official Board. They do <u>not</u> include the assets, equity, receipts, disbursements, etc. of any of the Church organizations (e.g. - UCW, St. James Players, etc.).

b) Expenditures of a capital nature are written off in the year of acquisition (\$379 in 2022).

2. MISSION AND SERVICE

All Mission and Service receipts are forwarded to the United Church of Canada at the end of the month in which they are received (\$8,563 in 2022). Money received for the Food Bank is forwarded to Kawartha Food Share twice a year (\$570 in 2022).

3. MANSE PROCEEDS

The proceeds from the sale of the Princess St. manse (\$38,000) are invested in a GIC. The interest earned on this GIC is included in the current general fund receipts (interest line).

It does include one-time visitors/donors such as those who attended funerals, Christmas Eve and/or Easter services, etc.; all of these were negatively impacted by COVID 19 in 2021 and 2022, resulting in fewer visitors/donors to the church since our last "normal" year (2019). This would include almost all the people in the \$0 to \$100 range above. In addition, some of our regular members did not attend as much in 2021 and 2022, again due to COVID 19, with a resulting drop in contributions from some of them.

Total number of **envelope holders** in 2022: 64; this number is included in the total number of donors above; in 2021, there were 67 envelope holders. This number has dropped over the past few years due to deaths, people moving, members going on PAR, etc.

Average annual donation in 2022 (includes envelopes, PAR, in memoriam donations, one-time visitors, etc.) per donor (not per envelope holder): \$1,091 (2021: \$1,456).
